Statement of Faith

1. The Bible

We believe the Bible to be the inspired and the only infallible, authoritative, inerrant Word of God, and the final authority in faith and life (2 Timothy 3:16-17, 2 Peter 1:20-21).

2. The Trinity

We believe in the deity of Christ (John 10:33), His virgin birth (Isaiah 7:14, Matthew 1:23, Luke 1:35), His sinless life (Hebrews 4:15, 7:26), His miracles (John 2:11), His vicarious and atoning death (1 Corinthians 15:3, Ephesians 1:7, Hebrews 2:9), His resurrection (John 11:25, 1 Corinthians 15:4), His ascension to the right hand of God (Mark 16:19), and His personal return in power and glory (Acts 1:11, Revelation 19:11).

4. Salvation

We believe that the Lord Jesus Christ died as a representative and substitutionary atonement, fully justifying all those that repent of their sins and put their faith in Him. By God's grace we are saved by faith alone. We believe believers have the presence of the Holy Spirit indwelling in them enabling them to live a Godly life (John 1:12-13, 3:16; Ephesians 1:7, 2:8-10, 4:30; Romans 3:23, 8:13-14, 10:9-10; 1 Corinthians 3:16).

5. Eternal State

We believe in the resurrection of both the saved and the lost; that they are saved unto the resurrection of life (Heaven), and that they are lost unto the resurrection of condemnation (Hell). (John 5:28-29)

6. The Body
